Indiana Launches Hospital Staffing Tool, Looks to Expand Scope

(Beckers Hospital Review)

A statewide staffing tool **launched** by the Indiana Hospital Association this year received interest both from members and other state hospital associations, but adoption by hospitals has been slow so far.

The staffing resource tool was developed alongside Matchwell, a company that focuses on matching local and per diem clinicians to healthcare facilities. Indiana Hospital Association members have direct access to the platform, which allows them to view available, vetted clinicians who are looking for shift or contract jobs, according to the release. From within the platform, providers can also access tools to manage their workforce additions.

Clinicians who want to join the Rolodex of professionals seeking contract or shift work can also add themselves to the list **via the app**.

Hospital Caseload Strain May Have Contributed to 1 in 5 COVID Deaths

(CIDRAP)

Strain from hospital caseloads played a role in one in five COVID-19 deaths, even after facilities had weathered and learned from earlier virus waves, researchers based at the US National Institutes of Health Clinical Center reported today.

One of their goals was to examine if fatal outcomes for COVID patients varied by different hospital types, from larger, more advanced facilities to smaller hospitals. Reporting in the <u>Annals of Internal Medicine</u>, they found that high caseloads had a negative impact on survival across all four hospital types they looked at.

Camden County Sees Significant Drop in Overdose Rates

(Camden County Board of Commissioners)

Recently, the NJ ROIC-Drug Monitoring Initiative released its annual report for the first half of 2024 and found that from January to July, Camden County has experienced a 39% drop in overdose deaths compared to last year. This incredible progress proves that the expansive initiatives enacted by the Board of Commissioners and several community partners are having a real, tangible impact on the community.

"We have worked tirelessly to combat this insidious epidemic and to see in real time that our efforts are working is an indescribable feeling," said Commissioner Director Louis Cappelli Jr. "This report shows that curbing overdose is possible through a variety of harm reduction measures such as making Narcan and medically assisted treatment, widely available. Furthermore, what can't be discounted is the wide range of educational initiatives we have funded and produced to warn the public of the deadly impact of fentanyl."
