Emergency Manager of the Year Characteristics:

This award recognizes and honors the individual or program that has demonstrated leadership, partnership, selflessness, and ingenuity in New Jersey emergency preparedness programs by investing time and talent to make positive change in our profession by:

- Providing leadership that inspires other members to excel or make the impossible happen;
- Developing and implementing new, highly effective and creative programs;
- Engaging in collaborative efforts to further emergency management programs and activities;
- Exhibiting dedication to the betterment of the emergency management field in the State of New Jersey as evident by substantially influencing emergency management efforts state-wide;
- Helping individuals grow and achieve goals and objectives as a mentor or leader of volunteers involved in emergency preparedness, response or recovery;
- Working for positive long-term changes within our profession;
- Applying innovative ideas and/or creative techniques that enhance local and regional emergency management programs;
- Managing extraordinary response and recovery efforts to major disasters;

Any individual, or group, active in emergency management activities in New Jersey are eligible. The award is open to all who work in the field including planners, public health, NGOs, contractors, PIOs, first responders, etc.

New York Blood Center Enterprises Cybersecurity Incident Update

(New York Blood Center Enterprises)

On Sunday, January 26, New York Blood Center Enterprises and its operating divisions identified suspicious activity affecting our IT systems. We immediately engaged third-party cybersecurity experts to investigate and confirmed that the suspicious activity is a result of a ransomware incident. We took immediate steps to help contain the threat and are working diligently with these experts to restore our systems as quickly and as safely as possible. Law enforcement has been notified. We understand the critical nature of our services, and the health of our communities remains our top priority. We remain in direct communication with our hospital partners and are implementing workarounds to help restore services and fulfill orders.

We remain incredibly grateful for the generous response of our greater blood community – including our hospital partners, hospital associations, blood centers across the country, the AABB Interorganizational Task Force, and our donors – who have all come together to help advance our shared mission.

Preparing the Supply Chain for Disaster

(Healthcare Purchasing News)

Due to the sensitivity and critical importance of their work, healthcare facilities are especially vulnerable to disasters of both the manmade and natural varieties.

According to the Office of the Director of National Intelligence, the number of ransomware attack claims worldwide rose 74 percent in 2023 compared with 2022. Specifically, ransomware attacks against the healthcare sector "nearly doubled" over that span, "reaching a total of 389 claimed victims in 2023 compared with 214 in 2022." In the U.S. specifically, attacks against the healthcare sector were in fact "up by 128 percent." Cyberattacks lead to any number of issues, including delays in medical procedures, disrupted patient care due to multiweek outages, and "strained acute care provisioning and capacity."

A major cyberattack on Change Healthcare in late February of 2024 brought these issues into full relief. According to the House Energy & Commerce Committee, Change Healthcare, a subsidiary of UnitedHealth "acts as a clearing house for 15 billion medical claims each year accounting for nearly 40 percent of all claims." The cyberattack knocked them completely offline, creating a "backlog of unpaid claims" and resulting in "serious cashflow problems" at doctors' offices and hospitals.

Emergency managers, emergency services personnel, and individuals who are part of the emergency preparedness communities at all levels of government, private sector, or volunteer organizations need to be able to use the fundamentals of exercise simulation and design as an integrated system of resources and capabilities.

This course is designed to develop exercising skills in the following areas:

- Components of the Homeland Security Exercise and Evaluation Program (HSEEP)
- Exercise process application
- Comprehensive exercise program (exercise program management) application
- Exercise design steps application
- Major accomplishments in designing and implementing an exercise
- Purpose and application of various exercise documents
- Tabletop, functional, and full-scale exercises
- Exercise design applications for tabletop, functional, and full-scale exercises


