Thank you for joining us at the Operation Lights Out Medical Response Surge Exercise (MRSE) on Tuesday, March 11th, 2025.

The collaboration and problem solving we saw and heard throughout the exercise underscores the New Jersey Healthcare Coalitions' (NJHCC) purpose. We hope this exercise allowed you the opportunity to further refine your response and recovery structure while collaborating with other healthcare teams in your respective region(s).

Additional EMResource Survey for Acute Care Players:

As part of the MRSE assessment, we're asking the participating acute care players to fill out a brief additional EMResource survey that asks facilities to indicate whether or not they had sufficient staff, supplies, etc.

This survey should take less than five (5) minutes to complete and is made up of a series of "Yes/No" questions. If you've participated in previous MRSE exercises, this is the "Supplies, Staff, Stuff" survey that we traditionally open up following the MRSE.
